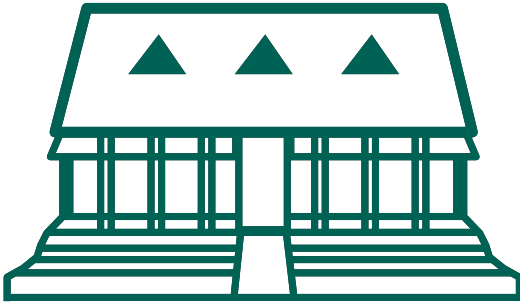

CODE OF CONDUCT

SL&GC has detailed rules and guidelines that govern Club activities such as swimming, boating, fishing, and social activities in addition to a guest policy which ensures the safety of all members and guests. The following is a brief summary of the most important policies.

1. Maintain polite and orderly behavior, be considerate of others at all times.
2. Follow lifeguards' water safety instructions without exception.
3. Unruly behavior by children may result in discharge.
4. No alcohol consumption under age 21; prohibited on the Dock before 5:00 PM.
5. Children must not be left unattended; specific age-related rules apply.
6. No amplified music, smoking/vaping, candles, or open flames allowed.
7. Cell phone usage is restricted; calls must be taken away from the Dock.
8. Personal belongings must be taken home daily – Club is not responsible.
9. Prohibited areas include the dam and Lake Road.
10. Guest policy strictly enforced; adults limited to three total visits per year.

Behavior that is in violation of our Code of Conduct is unacceptable. We expect members to be well-versed on all Club rules and policies, and to hold their children and guests accountable. The Board and Club management take these matters seriously and are committed to preserving the culture and values of our Club by providing a caring, friendly, and safe environment for all our members and guests. Failure to comply with Club Rules may result in suspension from the Club for not less than two weeks.

BY ORDER OF THE SL&GC BOARD OF GOVERNORS

CLUB RULES & REGULATIONS

GENERAL

1. Members and their children are expected to behave in a polite and orderly fashion, with consideration for other members, guests and employees, at all times while on the Club premises. Names of those persons violating this rule will be reported to the Board of Governors.
2. Members and their children will comply with the lifeguard's directions regarding matters of water safety. Anyone disregarding such directions will be asked to leave the Club.
3. Unruly children will be discharged from the Club grounds and may not return unless accompanied by an adult responsible for their orderly behavior.
4. Consumption of alcoholic beverages on Club premises by those below the age of 21 is prohibited. Glass bottles or containers are not permitted in the swimming area.
5. Consumption of alcoholic beverages around the Boathouse before 5:00 PM is prohibited except with permission from the Board of Governors for special occasions. In addition, consumption of alcoholic beverages in the swimming area is prohibited at all times.
6. Children under 12 shall not be left alone on the premises before 9:00 AM, after 5:00 PM, or when lifeguards are off duty!
7. No child under 7 years of age may be left alone anywhere at the Club without a competent babysitter. If such a child is left in the care of an older sibling or babysitter, the lifeguards must be informed.
8. Children ages 7 to 12 must pass the Little Raft Test to be left alone anywhere on the premises, and then only when a lifeguard is on duty.

CLUB RULES & REGULATIONS

GENERAL

9. The dam and road are out of bounds.
10. Dogs are never allowed on the dock or in the Boathouse, but are permitted on Club grounds during the off-season from November 1 through May 1. Please be considerate of others and pick up after your dog.
11. No radios or amplified music are allowed on the premises.
12. Vehicles must follow a clockwise course en route past the Boathouse and are not permitted to park in the picnic area.
13. Smoking, vaping, candles, and open flames are prohibited at all times in the Boathouse and on the dock.
14. All personal belongings must be taken home each day. Any items left at the Club overnight must be retrieved from the Lost & Found.
15. Children are to be picked up by a parent or guardian and may not leave the Club with any staff member.
16. Members who do not pick up their children by the 5:00 PM closing time will be charged a fee equal to the costs the Club incurs to remain open.
17. Members are responsible for removing their garbage from the premises after picnicking.

BOATING

1. Children who have passed the Big Raft Test may have rowboat privileges.
2. Children who have boating privileges must stay within sight of the Boathouse unless they are accompanied by a lifeguard or an adult.
3. Boating privileges will be suspended for anyone capsizing a boat except when being tested by lifeguards.
4. All kayaks and paddleboards must be properly stored and cleaned out after use. This includes securing the Kayak room when lifeguards are not on duty.
5. Children 13 years of age and under are required to wear a lifejacket at all times while boating. Children over 13 must also wear a lifejacket if they have not passed the Big Raft test. There must be a lifejacket for every passenger in the boat.
6. Electric motors are not permitted except for use by Club personnel.

SWIMMING

1. **ROPED AREA** - Children will not be allowed beyond the roped area until they have passed the Little Raft Test or are accompanied by an adult.
2. **LITTLE RAFT** - Children who are eligible may swim to the Little Raft with the approval of the lifeguard on duty.
3. **BIG RAFT - ALL SWIMMERS** going to the Big Raft must notify the lifeguard on duty and are encouraged to swim with another member or guest.
4. **WHEN NO LIFEGUARD IS ON DUTY**, children under 18 years of age shall not swim unless accompanied or actively supervised by an adult, and adults are strongly urged to swim with another member or guest. Swim at your own risk!

FISHING

1. No fishing off the main dock. Anglers may fish from boats or off the fishing dock and are expected to clean up their equipment, especially line and hooks that pose a danger to other members and wildlife.
2. Neither fishing nor equipment is allowed in the sandbox area at any time.
3. All state of New Jersey fishing laws and regulations must be observed including the possession of licenses.

LAKE GUEST POLICY

The guest policy is intended to ensure that all members can comfortably enjoy the Lake while preserving the relaxed atmosphere that defines our club.

General Guidelines

- **Accompaniment:** Members are welcome and encouraged to bring guests, provided that all guests are accompanied by a member at all times.
- **Arrival and Registration:** Upon arrival, guests must be signed in using the Boathouse Guest Log or by scanning the QR code [below-(only for website)], and introduced to the Club Manager or staff on duty.
- **Visitation Limits:** Adult guests are limited to a maximum of three (3) visits per year, regardless of which member is hosting them. Children have no visitation limits, except that they are limited to attending one full week of camp as a guest.

Guest Fee & Facility Use

- **Facility Use (\$10 Daily Fee):** A daily guest fee of \$10 applies to any guest using the facilities. Facility uses include: water activities (swimming, boating, fishing), the sandbox, ice-skating, and rackets (tennis, paddle, pickleball).
- **Picnicking (No Fee):** Guests who are solely visiting to picnic anywhere on the grounds, and do not use the facilities mentioned above are welcome at no charge.

Group Gatherings

- **Definition:** Any gathering of more than 12 guests per party is considered a “Group Event.” This applies regardless of how many host members are present.
- **Registration:** All Group Events must be registered in advance with the Club Manager. Large, unregistered gatherings of more than 12 guests are not permitted.
- **Approval & Fees:** Event approval is subject to scheduling, facility capacity, and overall member use of the Lake Club on and around that day. Standard guest fees or private party rentals will apply to attendees using the facilities.

CLUB RENTALS

Private Parties

The In-Season Calendar runs from May 1st through October 1st with all other times considered off-season. All Club rentals are subject to availability, Board approval, and submission of a signed rental agreement. Please contact the Club Manager at: **manager@ravinelake.com** if you are interested in making private party arrangements.

All parties of 75 people or more are automatically designated as an **Entire Club Rental** which includes the Boathouse and Picnic Area.

Picnic Tables:

Two Tables: Free, with a maximum of 8 people at each table.

Additional Tables: \$50 each, up to a maximum of 5 tables total.

The \$50 fee is for picnicking only. If you plan to use courts, boats, or swim, additional guest fees will apply.

Rental of the Entire Club or Boathouse will be limited to **one** event per month for in-season. Only **two** events may take place in September and off-season.

No corporate events or fundraisers may take place during the in-season time period and any corporate or fundraising events that take place in the off-season will be charged in-season rates.

MEMBERSHIP CATEGORIES

REGULAR MEMBERS (REG):

All members join as a Regular Member and pay an initiation fee, annual dues, assessments, if any, and have full voting rights.

SENIOR MEMBERS (SR):

Senior Members are Regular Members who have been members for at least 15 years, are over the age of 65 as of April 1 of the current year and have no children or grandchildren currently living at home. Senior Members have full voting rights.

JUNIOR MEMBERS (JR):

Juniors Members are between the ages of 25 and 35 as of April 1 of the current year and the children of current Regular Members. Junior Members have full voting rights. Initiation fee is waived until acceptance to Regular Membership at age 35.

NON-RESIDENT MEMBERS (NR):

Non-Resident Members are Regular Members who have moved to a distance of 50 miles or more from the Club. They do not have voting rights.

HONORARY MEMBERS (HON):

Honorary Members must be 80 years of age and must have been distinguished Regular Members for at least 50 years. They do not pay dues and are not entitled to vote.

Any resignations or requests for changes in membership need to be sent in writing to the Membership Chair no later than April 1st of the current year.
